MEMORANDUM OF ASSOCIATION

- I. The name of the Company is "KANTA RUBBER PRIVATE LIMITED."
- II. The Registered Office of the Company will be situated in the State of Andhra Pradesh.
- III. The objects for the which the Company is established are :
 - (A) THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE :
 1. To manufacture, manipulate, treat and prepare rubbers, rubber products, rubber by-products, PVC products, & PVC by-products, repairing materials and all allied commodities in all their stages and varieties and to buy, sell, import, export and deal in all such commodities, whether manufactured by the Company or otherwise.



3. To manufacture, manipulate, treat and prepare polymers, polymer products, by-products and allied commodities in all their stages and varieties and to buy, sell, import, export and deal in all such commodities, whether manufactured by the Company or otherwise

4. To manufacture, manipulate, treat and prepare meta zinc oxide and other chemicals used in the mixing of rubber and PVC product & PVC by-products in all stages and varieties and to buy, sell, import, export and deal in all such commodities whether manufactured by the Company or otherwise.

(B) THE OBJECTS INCIDENTAL OR ANILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS :

1 a) To acquire wholly or in part, ownership or control or management or all of the above of any partnership firm, sole proprietary concern and the like carrying on any business which this Company is authorised to carry on,

To enter into partnership or any other arrangement for sharing profits, union of interest, co-operation, joint venture or reciprocal concession, with any person or Company carrying on or engaged in any business or transaction which this Company is authorised to carry on or engage in any business or transaction capable of being conducted so as directly or indirectly to benefit this Company and to lend money to, guarantee the contracts of, or otherwise assist any such person or Company, and to take or otherwise acquire shares or securities of any such Company to sell, re-issue with or without guarantee, or otherwise to deal with the same.

2. To promote any company or companies for the purpose of acquiring all or any of the property, rights and liabilities of this Company, or for any other purpose which may seem directly calculated to benefit this Company.

3. Generally to purchase, take on lease or in exchange, hire or otherwise acquire, any movable or immovable property, and any rights or privileges which the Company may think necessary or convenient for the purpose of its business and in particular any lands, buildings, leaseholds, machinery, plant and stock-in-trade.

4. To construct, maintain or alter any buildings, factories, ware-houses, godowns, shops or other structures or works necessary, convenient or expedient for the purpose of the Company.

5. To purchase and sell in India or elsewhere any materials of any description on commission or otherwise, and to undertake or execute any work on commission or by contract or otherwise.

6. To employ or otherwise acquire technical experts, engineers, mechanics, foremen and skilled and unskilled labour for any of the purposes of the business of Company



7. To sell, improve, manage, develop, exchange, lease, mortgage, enfranchise, dispose of, turn to account, or otherwise deal with, all or any part of the property and rights of the Company.
8. To apply for, purchase or otherwise acquire any patents, brevetted invention, licences, concessions and the like, conferring any exclusive or non-exclusive of limited right to use, or any secret or other information as to any invention which may seem capable of being used for any of the purposes of the Company, or the acquisition of which may seem calculated directly or indirectly to benefit the Company, and to use, develop or grant licences in respect of, or otherwise turn to account the property, rights or information so acquired.
9. To enter into arrangements with any Government or authorities, supreme, municipal local or otherwise, that may seem conducive to the Company's objects, or any of them and to obtain from any such Government or authority, any rights, privileges and concessions which the Company may think it desirable to obtain and to carry out, exercise and comply with any such arrangements, rights privileges and concessions.
10. Generally to carry on the business as financiers and guarantors and to undertake and to carry out all such operations and transactions (except Insurance business within the meaning of the Insurance Act and business of Banking) within the meaning of the Banking Regulations Act, as an individual capitalist may lawfully undertake and carry on.
11. To apply for, tender, purchase or otherwise acquire contracts, sub-contracts, licences and concessions for all or any of them and to undertake, execute, carry out, dispose of or otherwise turn to account the same and to sub-let all or any contracts from time to time and upon such terms and conditions as may be thought expedient.
12. To pay for any business, property or rights acquired or agreed to be acquired by this Company and generally to satisfy any obligation of this Company by the issue of or transfer of shares of this Company, or any other Company credited as fully or partly paid up or of debentures or any other securities of this or any other Company
13. To accept payment for any property or rights sold or otherwise disposed of or dealt with by the Company, either in cash by instalments or otherwise, or in respect of dividends or payment of capital or otherwise, or in debentures or debenture-stock or other securities of any company or Corporation, or by mortgage, or partly in one mode and partly in another and generally on such terms as the Company may determine, and to hold deal with or dispose of any consideration so received.
14. To pay, satisfy or compromise any claims made against the Company, which it may seem expedient to pay, satisfy or compromise, notwithstanding that the same may not be valid in law.
15. Subject to the provisions of Section 58 of the Companies Act, and the rules made thereunder and the directives of Reserve Bank of India to receive money on deposit with or without allowance of interest, to advance and lend moneys upon such



securities or without securities therefore as may be thought proper and to invest such of the Company's money not immediately required in such manner as may from time to time be determined by the Directors or the Company.

16. To borrow and secure the payment of money in such manner and on such terms as the Directors may deem expedient, and mortgage or charge the undertaking and all or any part of the property and right of the Company, present or future including uncalled capital.
17. To open an account or accounts with any person or Company, or with any bank or bankers or shroffs and to pay into, withdraw moneys from such account or accounts whether they be in credit or otherwise.
18. Subject to the Banking Regulation Act 1949 to draw, make, endorse, discount, execute and issue, negotiate, assign, buy and sell or otherwise deal in cheques, drafts, promissory notes, bills of exchange, hundies, debentures, bonds, bills of lading, railway receipts, warrants and coupons and all other negotiable and transferable securities, instruments and documents.
19. To remunerate any person or company for services rendered, or to be rendered, in placing or assisting to place or guaranteeing the placing of any of the shares in the Company's capital, or any debentures, debenture-stock or other securities of the Company, or in or about the formation or promotion of the Company, of the conduct of its business.
20. To adopt such means for making known the business and/or product of this Company or any company in which this Company is interested as its agent representative or in any other way, by advertisement in papers, periodicals, magazines, through cine slides and films, by issue of circulars, posters, calendars showcards, playing cards, boardings, by radio programme, exhibiting by publication of books periodicals and by granting prizes, rewards and donations.
21. To establish, aid, support funds and institutions calculated to benefit employees or ex-employees or the dependents or connections of such persons, and to grant pension and allowances, and to subscribe or guarantee money for charitable objects.
22. To provide for the welfare of the directors, officers, employee and ex-officers of the Company and the wives, widows, and families or the dependants or connections of such persons, by building or contributing to building of dwellings, or chawls, or by grant of money, pensions, houses, allowances, bonus or other payments, or by creating and from time to time subscribing or contributing to provident or other associations, institutions, funds or trusts and by providing or subscribing or contributing towards places of instruction and recreation, hospitals and dispensaries, medical and other attendance and other assistance as the Company shall think fit and to subscribe, or contribute or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, national, public or other institutions and objects which shall have any moral or other claim to support or aid by the Company either by reason of locality of operation or of public and general utility or otherwise.



23. To create any depreciation fund, reserve fund, or any other special fund whether, for repairing improving, extending or maintaining any of the property of the Company or for any other purpose conducive to the interest of the Company.
24. To procure the registration or other recognition of this Company in any country, state or place and to establish and regulate agencies for the purpose of the Company's business
25. To amalgamate with any other Company having objects altogether or in part similar to those of this Company.
26. To sell or dispose of the undertakings of the Company or any part thereof for such consideration as the Company may think fit and in particular for shares, debentures or securities of any other companies having objects altogether or in part similar to those of this Company.
27. Subject to the provisions of Section 511 of the Companies Act, 1956, to distribute any of the property of the Company amongst the members in specie in kind and in particular by the distribution of paid-up shares or debentures, or debenture stock of the Company or any other Company for bonus or any portion of capital declared or due but so that no distribution amounting to a reduction of capital shall be made except with sanction (if any) for the time being required by law.
28. Subject to the provisions of Act, to place, to reserve or to distribute as dividends or bonus among the members or otherwise to apply as the Company may from time to time think fit, any moneys received by way of premium on shares or debentures issued at a premium by the Company, any moneys received on the sale by the Company of forfeited shares or from unclaimed dividends.
29. To do all or any of the above things in any part of the world, and either as principals, agents, trustees, contractors or otherwise and either alone or in conjunction with others and either by or through agents, subcontractors, trustees or otherwise.
30. To do all such other things as are incidental or conducive to the above objects or any of them.

(C) OTHER OBJECTS :

1. To carry on business as manufacturers of and dealers in chemicals of high purity, used in electronic industry, polymers, blowing agents, leather chemicals, anticorrosive agents, antioxidants for laboratory and industrial use, electronic and digital equipment, solar energy appliances and wind mills.
2. To undertake and execute any contracts for works involving supply or use of any machinery and to carry out any auxiliary or other works comprised in such works.
3. To establish and maintain transport services and transport facilities.
4. To carry on the business as agriculturists, planters, cultivators of Rubber, Tobacco Groundnut, Paddy, Castor and or any other kind of produce.



5. To acquire, buy, sell, hire, let on hire or otherwise deal in any movable or immovable property which the Company may think it favourable by way of investment or with a view to resell or otherwise.
6. To cultivate, develop, turn to account, grow, produce or deal in any vegetables, or vegetable products and to carry on all or any of the business of farmers, dairy-men, Milk contractors, dairy farmers, millers, purveyors and vendors of milk, cream, cheese, butter, poultry and provisions of all kinds, growers of and dealers in corn, hay and straw seedsmen and nurseryman and to buy, sell and trade in any goods usually traded in any of the above businesses, or any other business associated with the farming interest which may be advantageously carried by the Company.
7. To carry on the business of general Merchants, importers, and exporters, shippers, traders, commission Agents and manufacturers Agents and any other trade or business in any goods or classes of goods whatsoever.

The Liability of the Members is limited.

The authorised share capital of the company is Rs.50, 00,000/-(Rupees Fifty Lakhs only) divided into 50,000/-(Fifty thousand only) equity shares of Rs.100 (Rs. Hundred Only) with power for the company to consolidate, convert, subdivide, reduce or increase the capital and to issue any shares with any preferential or special rights and conditions attached thereto subject to the provisions of the companies act, 1956.

Articles of Association
of
Kanta Rubber Private Limited

1. The regulations in Table 'A' of the First Schedule to the Companies Act, 1956, so far as they are applicable to private company, shall apply to this Company save in so far as they are expressly or impliedly excluded by the following articles.

PRIVATE COMPANY

2. The Company is private limited company within the meaning of Section 3 (I) (iii) of the Companies Act 1959 and accordingly :
- a) The right to transfer the shares of the Company shall be restricted.
 - b) The number of members of the Company shall be limited to fifty not including.
 - i) Persons who are in the employment of the Company; and
 - ii) Persons who having been formerly in the employment of the Company, were member of the Company while in that employment and have continued to be member after the employment ceased.
 - c) No invitation shall be issued to the public to subscribe for any shares in or debentures of the Company.



SHARE CAPITAL

3. The authorised share capital of the Company is Rs. 25,00,000/- (Rupees Twenty Five Lakhs) divided into 25,000 (Twenty Five Thousand) Equity Shares of Rs. 100/ (Rupees one hundred) each. The company may increase or reduce the capital and divide the shares in the capital for the time being into several classes and attach there to respectively such preferential qualified or special rights, privileges, or condition in such manner as the Board of Directors may deem fit from time to time.
4. The shares shall be under the control of the Directors, who may allot and issue the same to such persons on such terms and conditions and at such time as the Directors think fit.
5. Save as herein otherwise provided the Company shall be entitled to treat registered holder of any shares as the absolute owner thereof and accordingly shall not except as ordered by a court or competent jurisdiction or as required by statute be bound to recognise any equitable or other claim to or interest in such share on the part of any other persons.
6. The Directors may allot and issue shares in the capital of the Company as payment or part-payment for any property sold or transferred, good or machinery and appliances supplied, or for services rendered to the Company in or the acquisition and or conduct of its business, and any shares which may be so allotted, may be issued as fully paid-up shares and if so issued shall be deemed to be fully paid-up shares.
7. If two or more persons any registered as joint holders of any share they shall be severally as well as jointly liable for any call or other liability in respect of such share, but the first named upon the Register shall, as regards voting, proxy and service of notices, be deemed the sole owner thereof. Upon the death of a registered joint holder the surviving joint holder shall be deemed by the Company to be absolutely entitled to the share.

L I E N

8. The Company shall have first had paramount lien upon all the shares (whether fully paid or not) registered in the name of each member (whether solely or jointly with other) and upon the proceeds of sale thereof for his debts, liabilities and engagements (whether presently payable or not) solely or jointly with any other persons to or with the Company, whether the period for the payment fulfilment or discharge thereof shall extend to all dividends from time to time declared in respect of such shares. The Board of Directors may at any time declare any share to be wholly or in part exempt from the provisions of this clause.

CALLS ON SHARES

9. A call may exceed one-fourth of the nominal value of the share and be made payable within such dates as may be decided by the Board.

TRANSFER OF SHARES

10. The directors shall in their absolute discretion, have power to refuse to register the transfer of any person without assigning any reason if in their opinion such transfer is undesirable to the interest of the Company.
11. The Company may in General Meeting by special resolution call on any member to transfer all or any of his shares or a share to some person either selected at the meeting or to be nominated there-after by the Directors at a fair value determined by the members.



12. The Company shall incur no liability whatever in consequence of their registering or giving effect to any transfer of shares made or purporting to be made to the prejudice of persons having or claiming any equitable right, title or interests to or in the shares notwithstanding that the Company may have had notice of such equitable right or title or claim or notice prohibiting registration of such transfer
13. A General Meeting of the Company may be called by giving seven days notice in writing,
14. Two members personally present shall be a quorum. No business shall be transacted at any General Meeting unless a quorum of members is present.
15. In pursuance of Section 170 of the said Act, Section 173 (2) and 173 (3) shall not apply to the Company and accordingly where any special business is to be transacted at General Meeting there shall be no need to annex to the notice of the meeting of any explanatory statement.
16. No member shall be entitled to vote any general meeting unless all calls or other sums presently payable by him in respect of his shares in the Company have been paid'
17. Unless otherwise determined by the Company in a general meeting, the number of the Directors shall not be less than two or more than nine including any nominated, technical, special, additional and alternate Directors if any, and including any other kind of Director on the Board.
18. The first Directors of the Company shall be as under and they shall be permanent Directors :
 1. SRI SUNIL KUMAR JAIN
 2. SRIBIMAL KUMAR JAIN
19. The Managing Director will be elected by the Board of Directors. Any vacancy in the office of the Managing Director, will be filled up by the Board of Directors.
20. No qualification shares are required for the Directors.
21. Retirement of Directors by rotation shall not apply.
22. The Directors shall have the right to fill up the casual or permanent vacancies in the Board.
23. Remuneration of the Directors and the Managing Director or Directors shall be fixed by the Board of Directors.
24. Each Director shall be paid out of the funds of the Company as remuneration for his services, such sums as may be determined by the Board of Directors for every meeting of the Board of Directors or that of any committee of the Board, attended by him besides travelling, hotel and other expenses, incurred in connection with the Company's works.



25. If any Director, being willing, shall be called upon to perform extra services or to make any special exertions in going or residing elsewhere or otherwise for any purpose of the Company, the Board shall remunerate the Directors so doing either by a fixed sum or by a percentage of profits: or otherwise as may be determined by the Board of Directors and such remuneration may be either in addition to or in substitution for his or their share in the remuneration above provided.
26. Two Directors present in person shall constitute the quorum for a Board Meeting to transact the business.

BORROWING POWERS

27. The Directors may, from time to time, at their discretion raise or borrow or secure the payment or any sum of money without limit, for the purposes of the Company. Any such monies may be raised and the payment or such monies may be secured in such manner and upon such terms and conditions in all respects as the Directors may think fit, and in particular by promissory notes, or by opening current account; or by receiving deposits and advances at interest with or without security, or by the issue of debentures or debenture stock of the Company charged upon all or any part of the property of the Company (both present and future) including its uncalled capital for the time being, or by mortgaging or charging or pledging any land, building, machinery, plants, goods, or other property and securities of the Company, or by such other means as to them may seem expedient.

INDEMNITY

28. Every Director, Officer or servant of the Company shall be indemnified by the Company and it shall be the duty of the Directors of the Company to pay all costs, losses and expenses which such Director, or other officer or employee may incur or become liable to may by reason of any contract entered into or act or thing done by him as such Director, Officer or employee or in any way in the discharge of his duties,

SEAL

29. The Board shall provide a common seal for the Company and it shall be used under the authority of the Board of Directors. Every deed or other instrument to which the seal of the Company is to be affixed shall be sealed in the presence of the Managing Director and one of the Directors who shall sign the same.

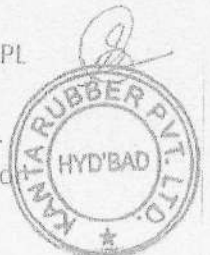

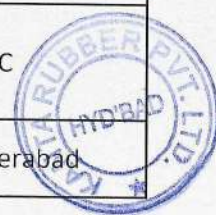
